Section 4. First aid measures

Inhalation : If inhaled, remove to fresh air.

Flash point : >93.3 °C (Closed cup)
Fire-fighting media and instructions : Use an extinguishing agent suitable for the surrounding fire.

Dike liquid for later disposal.

Special protective equipment for fire-fighters : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

Section 6. Accidental release measures

- Personal precautions** : Ventilate area of leak or spill. Do not touch damaged containers or spilled material unless wearing appropriate protective equipment (Section 8). Stop leak if without risk. Do not allow to enter drains or watercourses.

- Methods for cleaning up** : If emergency personnel are unavailable, contain spilled material. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway. Place spilled material in an appropriate container for disposal.
